# Council invests in car park improvements

Suffolk Coastal has announced plans to improve two of its car parks; Melton Riverside and Thorpe Road in Aldeburgh.

The work to Melton Riverside Car Park next to Melton Railway Station will involve doing a general clean-up of the parking and picnic area and some realignment of the parking area to create an additional 20 car parking spaces. The car park surface will then be re-dressed, increasing the total number of parking spaces to 50.

Work to this car park will be completed by Kier Construction and is due to start 26 November and is estimated to be completed by 13 January 2017, during this time the car park will be closed.

Once the work to this car park is completed, the Council hopes it will provide better access for regular users of the Country Park. The additional benefit of this work is that the refurbished car park will provide extra parking for those using the nearby facilities at the station and new

district council offices, providing additional public parking at times of peak demand such major planning meetings.

The work to Thorpe Road car park involves improving the drainage of the site and surface of the car park. The tarmac surface at the entrance of the car park will be increased to prevent standing water and the area will be given a new shingle surface to help the area drain more effectively.

The work to the car park is planned to start on 16 January and be completed in time for Easter.

Once the works have been completed, both car parks will receive ongoing maintenance by Suffolk Coastal Norse.

We have planned the works to both car parks to take place during the autumn and winter months to reduce the impact on our residents and visitors and aim to keep people informed throughout the process.

#### **International Fraud Awareness Week**

International Fraud Awareness Week started on Sunday (13 November) and three councils in Suffolk are highlighting their efforts to combat fraud and make it easier for both staff and public to report criminal behaviour.

Cyber fraud is a relatively new phenomenon but traditional methods of fraud are continuing and Ipswich Borough, Suffolk Coastal and Waveney District Councils are reminding everyone to be aware.

Under the banner "I Won't Stand For Fraud", the councils are urging everyone to be vigilant and to act if they suspect fraud is being committed.

Fraud can come in many guises:

- Do you suspect a tenant is sub-letting part or all of their home?
- Do you feel you should re-check a suspicious application form?
- Do you know of a business that could be involved in fraud?

It's important that everyone is aware of the problem of fraud as it affects all aspects of society. By developing a stronger, more collaborative approach we aim to encourage the public to become more confident in reporting fraud and to share issues of fraud easier to protect the public against scams in the future.

# Test your smoke alarm today

Residents in east Suffolk are being urged to test their smoke alarms today and then once per month.

According to recent research, only 28% of all UK households who own a smoke alarm test it on a regular basis. Having a working smoke alarm in your home gives you valuable time to get out of your home in the event of a fire.

There were 229 fire-related deaths in the home last year and it is hoped that encouraging people to test their smoke alarms now and then monthly could prevent more deaths.

To help keep you and your loved ones safe:

- Test your smoke alarm(s) today.
- Make sure you fit smoke alarms on each level of your home and test them monthly – even if they're wired into the mains.
- Never remove the battery in your smoke alarm unless you are replacing it.
- Plan and practise an escape route and make sure everyone in your home knows the plan.
- If you know of friends, family or neighbours who are unable to test their smoke alarms themselves, test it for them.

If you're a private landlord, you must fit at least one smoke alarm on each flood of the property you rent out. You must also fit a carbon monoxide alarm in any room with a solid fuel burner (eg a wood or coalburning fireplace).

- You can be fined up to £5,000 if you fail to fit the required alarms.
- You must test every alarm at the start of a new tenancy.

If you are a tenant in rented accommodation, your landlord is responsible for ensuring that there are working smoke alarms on every level of your home at the start of your tenancy. However, <u>you are responsible</u> (www.gov.uk/government/uploads/system/uploads/attachme nt\_data/file/475170/Fire-Safety-in-Shared-or-Rented-Accommodation.pdf) for testing your alarms monthly and replacing the batteries where necessary.

In the event of a fire, get out, stay out and call 999.

**Getting your recycling right.** A campaign is being launched on the 31.10.16 by the Suffolk Waste Partnership to highlight the importance of people getting their recycling right.

As part of the campaign, a leaflet is being sent out to every household in Suffolk to highlight what can and can't go in your recycling bin:

In Suffolk more than half of our household waste is recycled, but contamination levels have been rising as people increasingly put unsuitable items in their kerbside recycling bins. These items are potentially dangerous, can have a negative impact on the environment and ultimately cost the taxpayer extra money to clean up.

All recyclable waste collected from Suffolk households is taken to the Materials Recycling Facility (MRF) in Great Blakenham, where it is sorted and baled before being sent on for recycling. This facility is designed to only accept and process certain materials. If the wrong items are delivered they have to be removed, sometimes by hand.

To ensure the correct items are put into their recycling bins, residents across the county are being asked to remember the following points to combat contamination:

- Textiles and clothes can no longer go in the recycling bin, either bagged or loose. Instead people are asked to donate their clothing to charity shops, or to take it to their nearest recycling banks.
- Anything smaller than 4cm, such as loose bottle tops or shredded paper, won't get recycled as these items fall through the sorting process. However, bottle tops can be recycled by simply washing and squashing plastic bottles and putting the tops back on.
- Aluminium foil needs to be rolled into a tennis ball-sized ball before being placed in the recycling bin.
- Food waste, glass, electrical items, and batteries are just some of the common contaminants found. These items can't go in your recycling bin at home but they can be recycled elsewhere.
  Information on where they can be recycled are in the leaflet and online.

• Some people are even putting used nappies in their recycling bins. These must always go in the rubbish bin.

Cllr Clive Arthey, chairman of the Suffolk Waste Partnership, said:

"While it is great that we are recycling more than half of our household waste here in Suffolk, this campaign will hopefully help us improve the quality of Suffolk's recyclable material and save taxpayers money.

"For example, 1,500 nappies are picked by hand from people's recycling every day. This is a horrible job and spoils the other recyclables, costing both time and money to sort out. If you follow the advice in the leaflet and on our website and only put the correct items in your recycling bin, we can improve the quality of recyclables going to the MRF and will be able to recycle even more.

"Textiles and items of clothing are no longer being accepted in the recycling bins and we would ask people to take unwanted textiles to a charity shop, a recycling bank or their nearest Recycling Centre."

<u>Merger consultation</u> – A recent independent survey of 1,000 residents in the Suffolk Coastal and Waveney districts in October shows that a clear majority of people are in favour of a new council for east Suffolk.

The survey conducted by ComRes asked people a number of questions about the proposals. Four out of five respondents (78%) expressed a favourable or neutral view about the proposals and of those who "don't know" (20%), the majority then expressed a favourable view when provided with more information about the plans.

<u>Better Broadband</u> – The Better Broadband scheme has now extended its offer to people who currently get less that 2Mbps in their property and there are no other means of getting higher speeds.

As an alternative to an interim basic broadband service provided by satellite, residents and businesses may be eligible for a voucher to help

with the connection cost of an interim wireless broadband service from an Approved Supplier.

<u>Canvassers Calling</u> - Please make residents aware that official canvassers are now calling at homes in Suffolk Coastal where people have not yet responded to their annual voter registration form.

The forms were sent to all Suffolk Coastal households earlier this year. Residents are legally required to confirm or update the details of anyone at the address who is eligible to vote in the UK to ensure they are registered to vote for future elections.

Over 82% of households have now responded to the annual voter registration forms. Any household which has not yet responded will be visited by an approved Suffolk Coastal canvasser, between 17 October and 25 November.

All canvassers will carry identification and will be trialling iPads to record the information for the first time. Suffolk Police and Suffolk Coastal's Customer Services will have a list of approved canvassers. Anyone concerned about the identity of a canvasser can contact Suffolk Coastal Customer Services on: 01394 383789.

Canvassers will never ask residents for money, and anyone claiming to be a canvasser who is asking for money should be reported to Suffolk Police by calling 101.

### Councils to decide on devolution for Norfolk and Suffolk

SCDC Full Council Meeting on the 28.11.16.

Local councils are to decide on devolution for Norfolk and Suffolk.

Over the next two weeks, 12 councils across Norfolk and Suffolk and the New Anglia LEP will be asked to formally agree to become part of a Mayoral Combined authority for the two counties.

Councils and the LEP will be asked to agree to a draft order for approval by Parliament which covers the powers that Government is proposing to transfer to a Norfolk/Suffolk Mayoral Combined Authority (MCA) and how it would take its decisions. Leaders have been clear that the key decisions such as on how to spend the £750m investment fund and £130m housing fund and requests for additional powers from government must be supported by all the members of MCA.

The draft order was produced after the Secretary of State (SoS) for Communities and Local Government had considered a summary of the more than 10,000 responses to the consultation carried out during July and August. The SoS recognised the local support for Devolution and was satisfied that creating a Mayoral Combined Authority for Norfolk and Suffolk would improve outcomes for local communities.

The majority of consultation responses, 6080, were received via a telephone

survey carried out by Ipsos-Mori. The survey gained views from a cross section of people, reflecting the population of the two counties and highlighted strong support for more decisions to be taken locally across a range of issues. There was also majority support for setting up a MCA.

The same survey was also available via the Devolution and council websites with around 2900 people responding. Whilst there was less support for a MCA via this channel there was majority support for more decisions to be taken locally.

250 businesses of various sizes across the two counties were also surveyed by Mori and also showed clear support for more decisions to be taken locally by a MCA.

Andy Wood, Independent Chair of the Leaders Group said:

"Communities have told us that they want more decisions that affect them taken locally rather than by central government. Devolution would deliver exactly that - improving people's lives and the places in which they live. The Secretary of State has confirmed the Government's commitment to Devolution for Norfolk and Suffolk – locally, we must now seize this once in a lifetime opportunity.

There have been some concerns about those areas of Norfolk who would currently not be covered by the Combined Authority. The Secretary of State has been clear that once the Combined Authority has been formally established the four areas would be very welcome to apply to join, should they so wish.

It is also important to be clear that only if all the councils agree the draft order will devolution for the two counties proceed. In early September a strong message was sent to the North East where some councils voted against their proposed Devolution deal, which saw Government promptly withdraw the deal. The Secretary of State has clearly stated that this is one of the most ambitious devolution deals in the country. He has been equally as clear that if we don't agree the deal the funding on offer will be spent elsewhere in the country, where Devolution plans are agreed. We must not allow more than £1bn of funding slip through our fingers."

Key elements of the Norfolk/Suffolk deal are:

- £25m funding each year for the next 30 years (£750m) to support economic growth, development of local infrastructure and jobs (this would increase the local economy to £43bn and create 95,000 jobs by 2026)
- £130m investment over five years to support the building of new homes across Norfolk and Suffolk
- Over the lifetime of the deal around 200,000 homes could be delivered
- Control of a £225m transport budget for the next four years
- Control of an existing c£20m annual adult skills fund to ensure the training offer matches the needs of local businesses and the local labour market
- Control of an existing c£2m annual Apprenticeship Grant for employers

If all councils and the LEP approve the draft order a Combined Authority would be established from 1 March 2017 with Mayoral elections taking place on 4 May 2017.
