

Location: Sizewell B Sizewell Power Station Complex And Adjoining Land Sizewell Power Station Road Sizewell Leiston Suffolk IP16 4UR.

Proposal: Approval of Reserved Matters (Landscape) relating to Condition 2 of DC/20/4646/FUL - Hybrid application seeking outline planning permission, with all matters reserved, for up to 9,500 square metres Gross External Area (GEA) to provide administration, storage, welfare and canteen facilities and a visitor centre of up to 1,000 square metres GEA. Detailed planning permission is sought for demolition of some existing structures and redevelopment to include a training centre and interim visitor centre, an outage store, lay down area, car and cycle parking, landscaping, associated infrastructure (including utilities, plant and highway works), tree felling and other relevant works - Proposed visitor centre.

The Aldeburgh Town Council Response to the East Suffolk Council's Consultation on Jet Skis with the following points:

- a) **Licensing of Jet Skis:** Aldeburgh Town Council believes that Jet Skis should be licensed as a regulatory measure to ensure safety and control.
- b) **Conditions for Operation:** Aldeburgh Town Council proposes a complete ban on Jet Skis being used on the Alde and Ore, which are Ramsar-designated wetlands, to protect the sensitive environment.
- c) Minimum Specifications: N/a
- d) **Zones of Operation:** Aldeburgh Town Council recommends no launching or landing of Jet Skis within the Parish of Aldeburgh. Absolutely not to be used on the Alde and Ore.
- e) **Dates and Times of Operation:** Jet Skis should not be permitted to operate within the Parish of Aldeburgh at any time.
- f) **Enforcement of the Policy:** Aldeburgh Town Council suggests that East Suffolk Council display signage with information about penalties and fines, conduct irregular patrols, and enable the public to report non-compliance. Jet Ski license discs should also be clearly displayed in other areas where permitted.
- g) **Additional Comments:** Having received a comprehensive briefing note from the Alde & Ore for which the Committee was most grateful, Aldeburgh Town Council's Planning Committee concurs with the views, reasoning and evidence as presented.
